Board of Canvassers - 9:00 a.m.

Chairman Lonie R. Addis recessed the Board of Commissioners meeting at 9:02 a.m. and convened the Board of Canvassers to canvass the Primary Election of August 4, 2020. The Board of Canvassers confirmed the vote count of 3,631 of which were counted thru the DS450 Ballot Scanner and 5 hand count ballots. Election Clerk Becky Czapansky revealed the reasons for the ninety-two provisional ballots; thirty-three provisional ballots were counted.

Coordinated Transit District #10

Douglas Allen made a motion to authorize the Commissioners signatures on a prepared letter in support for transportation providers of Coordinated Transit District #10 in their application to the Kansas Department of Transportation for the funding in the coming year. Douglas Allen (Yes), Fred E. Vail (Yes). Also present was County Counselor Brian K. Johnson for a period of ten minutes to reconvene at 11:54 a.m.

Board of Canvassers

Chairman Lonie R. Addis recessed the Board of Commissioners at 12:00 p.m. and reconvened the Board of Canvassers. The provisional ballots were added to the totals bringing the grand total of votes cast to 3,669. The Board of Canvassers (Chairman Lonie R. Addis, Commissioner Fred E. Vail and Commissioner T. Douglas Allen) signed off on the August 4, 2020 Primary Election Abstract. (Total Registered Voters – 13,696 with 3,669 voters equals 26.78%) Chairman Lonie R. Addis adjourned the Board of Canvassers at 12:09 p.m.
