Parsons Economic Development Director Jim Zaleski – Shot Show Update

Parsons Economic Development Director Jim Zaleski gave Commissioners an update on the SHOT Show that he attended recently in Las Vegas, Nevada, to promote "Grow Labette County". Mr. Zaleski came away with some leads and felt it was a successful show.

Appraiser DeLinda White - Mail Issue

Appraiser DeLinda White met with Commissioners to explain why the Change of Valuation Notices that were to be mailed out on February 18th, had to be taken to a Mail Distribution Center in Wichita, KS, for mailing. On Monday, February 17th, the postage machine in the Treasurer's office quit working, according to County Treasurer Crystal Addis, who was also in the Commission meeting. The repairman for Pitney Bowes, was off that day due to President's Day, but said he would be in on Tuesday to check it out. It was unknown if the machine would be repaired before the close of business on the 18th. Notices were dated February 18th, therefore, the postmark on the envelopes had to be dated February 18th, so the decision was made to take the majority of the notices to the distribution center to ensure that State Statutes governing the mailing would be met. A few of the larger parcels were taken to the Post Office in Oswego to be postmarked.

Great Plains Industrial Park (GPIP/GPDA) – Updates

Park Director Brad Reams, gave an overview of the rail project that has been completed. The inspection was February 4th, and the first shipment arrived on February 10th. Project Manager Becky Dantic gave an update on the 5-year environmental review. Army Regulators were there as well as KDHE. They are working toward the move from the Resource Conservation Recovery Permit in place now, to a Corrective Action Permit with KDHE.

EMPG Grant Discussion

Emergency Manager Charles Morse spoke to Commissioners about the need for an EMPG Grant Title VI Civil Rights Plan required by the Federal Government to be eligible for the grant. Commissioner T. Douglas Allen made a motion to authorize the Chairman's signature on the Title VI Civil Rights Plan on behalf of Labette County. Fred E. Vail seconded the motion. The motion passed by vote: Lonie R. Addis (Yes), T. Douglas Allen (Yes), Fred E. Vail (Yes). Mr. Morse will send it in for the Commission Chairman's signature when he gets it filled out.

Emergency Manager Charles Morse also updated Commissioners on the information that he has gathered on the employee ID machine and its capabilities. Mr. Morse has learned that it now does have the option of making ID badges with RFID technology.

Emergency Manager Charles Morse also informed Commissioners that he has resigned his position as Vice-President of Southeast Kansas KEMA Board, citing reasons of not agreeing with some of the board decisions and his increasing County responsibilities.

Mr. Morse also mentioned that he will be attending the KSFA-KEHA Small Flows Annual Conference in Wichita, KS, February 26 – 28, 2020.

South Repeater Quote/CodeRED Service Agreement

911 Dispatch Director Brandy Grassl updated Commissioners on the quote from Commenco for repairs to the south repeater in Chetopa. Commissioner Fred E. Vail made a motion to approve payment of \$1,528.98, payable out of 911 Dispatch fund, to Commenco for service and parts, for the south repeater in Chetopa, KS. T. Douglas Allen seconded the motion. The motion passed by vote: Lonie R. Addis (Yes), T. Douglas Allen (Yes), Fred E. Vail (Yes).

911 Dispatch Director Brandy Grassl informed Commissioners that the IPAWS System, that will run through the CodeRED system already in place, has been approved through the state, but the service agreement with CodeRED needs to be updated so that it includes the IPAWS capability. The added service is included in the original cost of \$12,600.00 already contracted. Commissioner T. Douglas Allen made a motion to approve the Chairman's signature on the agreement between Labette County and ONSOLVE, LLC for IPAWS service. Fred E. Vail seconded the motion. The motion passed by vote: Lonie R. Addis (Yes), T. Douglas Allen (Yes), Fred E. Vail (Yes).

Ms. Grassl also discussed issues with the County Verizon phone plan. The current county policy requires an employee to utilize the free phones that Verizon offers. Verizon is having difficulty getting the model of Android phones that are free, and is offering a special deal on the purchase of a Samsung Galaxy 10 for \$29.99. T. Douglas Allen made a motion that authorizes employees to purchase this Android model during this time that the free phones are unavailable. Lonie R. Addis seconded the motion. The motion passed by vote: Lonie R. Addis (Yes), T. Douglas Allen (Yes), Fred E. Vail (No).

City of Edna - Street Project

Commissioner Fred E. Vail made a motion to authorize the Public Works Department to grind and crown twenty-two (22) blocks of streets in the City of Edna later this year, and to also haul rock. (This would just be for hauling the rock – the rock would be purchased from a third party by the City of Edna). The City of Edna would be using county equipment, and Public Work Employees hired by the City of Edna. This work would be done after normal working hours for Public Works, and the City of Edna would also be responsible for the fuel and equipment maintenance while it was being used by them. T. Douglas Allen seconded the motion. The motion passed by vote: Lonie R. Addis (Yes), T. Douglas Allen (Yes), Fred E. Vail (Yes).

He also discussed new security doors for his office. Mr. Jones is planning on replacing doors in the next few weeks for the conference room, the front door, and the back door.
