Audit Questions

Auditor Rodney Burns met with Commissioners to get clarification on a few questions that came up during the 2019 Audit. He questioned the reason the 014 Jail Housing fund was not being used, and Commissioners explained that they currently have no money coming into that fund, but that they may use it in the future. Mr. Burns also cautioned that the 123 Fund that pays for electricity for two street lights in Parsons, one located at Ness Rd. and Hwy 400, and one located at 24,000 Rd and Hwy 400, is close to being depleted. He also pointed out that the Sewer District #1 Maintenance Fund 318 has a negative balance.

Audit Engagement Letter – 2020
