VOTER REGISTRATION

You may register to vote at any of the following locations during their regular business hours: the Office of the County Clerk, Courthouse, Oswego or online www.labettecounty.com ; any City Clerk’s office; Department of Motor Vehicles; SRS offices, etc.; U.S. Mail (request Kansas Voter Registration Application by mail or telephone); also available in Online Voter Registration: www.voteks.org – Vote Kansas – online voter registration – follow thru as directed.

A citizen of the United States who is eighteen (18) years of age and upwards, or will have attained the age of eighteen (18) years at the next election, must register before he or she may vote.

When a voter has been registered according to law his or her registration shall continue to be valid until one of the following occurs:

1. The Voter changes residence, outside of his/her voting precinct boundary
2. The Voter fails to vote in two consecutive state general elections.

If either of the above occurs, you must re-register. Any person may apply in person or by mail to the County Election Officer to re-register. The application shall be signed under penalty of perjury.

CLOSING OF REGISTRATION BOOKS

Pursuant to the provisions of K.S.A. 25-2311, notice is hereby given that on the 12th day of July, 2022 (last day to register to vote before the August Primary) all registration books for the National/State/County/Local Primary Election will close at the end of regular business hours/day. The books will remain closed until the day following the Primary Election, August 3, 2022.

ADVANCE VOTING by MAIL: KSA25-1123

Any registered voter is eligible to vote by Advance Ballot, beginning Wednesday July 13, 2022 (20 days prior to said Primary Election) thru Monday Noon August 1, 2022. By Mail: Ballot must be postmarked on or before Tuesday, August 2, 2022 (Election Day) and received in County Election Office by Friday, August 5, 2022 Deadline for receipt of Advance Ballots. KSA 25-1132.

PARTY AFFILIATION CHANGES &/OR DECLARATIONS K.S.A.3304(a) &(b)

Deadline for party affiliation changes (from one recognized party to another/unaffiliated) before August Primary was 12 Noon, June 10, 2022. Such declarations cannot be filed from June 10 through September 1 (State Primary Election Certification).

An unaffiliated voter may affiliate by submitting a voter registration application or party affiliation change card any time between now and until/including Election Day.
