**Convene**

Chairman Vincent B. Schibi called the regular session of the Labette County Board of Commissioners to order at 9:00 a.m. on April 14, 2025, at the Commission Room. Attendance: Tom Barrett, Present, Vincent B. Schibi, Present, Terry Weidert, Present.

**Approval of Minutes**

Commissioner Tom Barrett made a motion to approve the minutes of April 7, 2025. Terry Weidert seconded the motion. The motion passed by vote: Tom Barrett (Yes), Terry Weidert (Yes), Vincent B. Schibi (Yes).

**Appraiser's Parcel Search Agreement – BC Max**

Commissioner Terry Weidert made a motion to authorize the Chairman's signature on an Appraiser's Parcel Search Agreement between Labette County and Brian Coltrane, BC Max; the fee of \$225.00 has been paid. Tom Barrett seconded the motion. The motion passed by vote: Tom Barrett (Yes), Terry Weidert (Yes), Vincent B. Schibi (Yes).

**Countywide Neighborhood Revitalization Plan Application**

**CA Credit Card Cancellation**

**Resolution 2025-25-L**

Commissioner Tom Barrett made a motion to authorize the commission signatures on Resolution 2025-25-L, prohibiting the installation of solar cells and solar cell arrays in Labette County, Kansas that were produced from forced labor under the UFLPA. This resolution shall take effect upon its publication in the county newspaper. Terry Weidert seconded the motion. The motion passed by vote: Tom Barrett (Yes), Terry Weidert (Yes), Vincent B. Schibi (No).
