Approval of Minutes



Rock Crusher Financing

Chairman Terry Weidert made a motion to authorize Public Works Director Sandy Krider to obtain bids from local banks for financing a 2022 Kleemann Advantage Rock Crusher with three, four and five-year financing options in the amount of \$699,900.00. Cole J. Proehl seconded the motion. The motion passed by vote: Cole J. Proehl (Yes), Vincent B. Schibi (Yes), Terry Weidert (Yes).
