The Board of County Commissioners, Labette County, Kansas, has heretofore, pursuant to resolution duly adopted, declared it advisable to continue (retain) the current one percent (1%) County Wide Retailer's Sales Tax for a period of five (5) years from July 1, 2021 through June 30, 2026.

NOTICE is hereby given to the qualified electors of the County that a special question will be submitted at the general election held on November 5, 2019 as follows:

### Shall the following be adopted?

Shall a County Wide one percent (1%) Retailer's Sales Tax be continued (retained) for a period of five (5) years from July 1, 2021 through June 30, 2026, all pursuant to the provisions of K.S.A. 12-187 *et seq.* for the purpose of property tax relief?

### VOTER REGISTRATION

You may register to vote at any of the following locations during their regular business hours: the Office of the County Clerk, Courthouse, Oswego or online [www.labettecounty.com](http://www.labettecounty.com); any City Clerk's office; Department of Motor Vehicles; SRS offices, etc.; also available in Online Voter Registration: [voteks.org](http://voteks.org) – Vote Kansas – online voter registration – follow thru as directed.

A citizen of the United States who is eighteen (18) years of age and upwards, or will have attained the age of eighteen (18) years at the next election, must register before he or she may vote.

When a voter has been registered according to law his or her registration shall continue to be valid until one of the following occurs:

1. The Voter changes residence, outside of his/her voting precinct boundary.
2. The Voter fails to vote in two consecutive state/federal general elections.

If either of the above occurs, you must re-register. Any person may apply in person or by mail to the County Election Officer to re-register. The application shall be signed under penalty of perjury.

**CLOSING OF REGISTRATION BOOKS (20 days before City/School General)**

Pursuant to KSA 25-2310, 25-2311 and KAR 7-23-4 notice is hereby given that on Tuesday, October 15, 2019 registration books for the City/School General Election will close at the end of the business day (last day to register to vote). The books will remain closed until the day following the General Election, Wednesday, November 6, 2019.

**ADVANCE VOTING by MAIL: KSA 25-1123**

Any registered voter is eligible to vote by Advance Ballot, beginning Wednesday October 16, 2019 (20 days prior to said General Election). Applications for Advance Ballots are available at the Labette County Clerk/Election Office, PO Box 387, Oswego, KS 67356 or by calling (620) 795-2138 or (620) 421-5255. A printable application for an Advance Ballot is available on the county website [www.labettecounty.com](http://www.labettecounty.com) or Secretary of State website [www.sos.kansas.gov](http://www.sos.kansas.gov).

**Tuesday, October 29, 2019, last day voter may apply for Advance Ballots (to be mailed) for General KSA 25-1122(e)(4).**

**RETURNING ADVANCE BALLOTS:**

**In Person:** Ballots must be returned by 7:00 P.M. on Election Day to any Polling Location within the County or to the County Election Office, Courthouse, 501 Merchant, Oswego, KS 67356.

**By Mail:** Ballot must be postmarked on or before Tuesday, November 5, 2019 (Election Day) and received in County Election Office by Friday, November 8, 2019 Deadline for receipt of Advance Ballots. KSA 25-1132.

**EARLY VOTING KSA 25-1122:**

Early voting (In House/In Person) is available at Labette County Courthouse 501 Merchant, Oswego (Clerk's Office) beginning Wednesday, October 16, 2019 thru Monday 12:00 Noon November 4, 2019.

**IMPORTANT NOTE:** All Voters must provide Valid Photo ID (Drivers' License, Military ID, Kansas College ID, Kansas ID or other qualifying ID card) to Vote. For a list of accepted identification and additional information go to [gotVoterID.com](http://gotVoterID.com) or call 800-262-VOTE.

The election will be conducted by the county election officer being the County Clerk as provided by law for holding elections, and the method of voting will be by ballot. Registered voters are eligible to vote by advance voting ballot upon application to the County Clerk of Labette County whose address is Labette County Courthouse, 501 Merchant/PO Box 387, Oswego, Kansas 67356 pursuant to K.S.A. 25-1117 *et seq.*
