**Convene**

Chairman Terry Weidert called the regular session of the Labette County Board of Commissioners to order at 9:00 a.m. on December 31, 2025, at the Commission Room. Attendance: Tom Barrett, Present, Vincent B. Schibi, Present, Terry Weidert, Present.

**Approval of Minutes**

Commissioner Tom Barrett made a motion to approve the minutes of December 22, 2025. Terry Weidert seconded the motion. The motion passed by vote: Tom Barrett (Yes), Terry Weidert (Yes), Vincent B. Schibi (Yes).

**BCBS 2026**

Commissioner Terry Weidert made a motion to authorize the Chairman's signature on the contract with a \$75,000.00 specific stop-loss and 120% aggregate stop-loss with the premium holiday. **Resolution 2025-47-A – Transfer from Road & Bridge Fund to Special Machinery Reserve Fund**

Commissioner Terry Weidert made a motion that the Board of Commissioners adopt and execute Resolution No. 2025-47-A transferring from the Road and Bridge Fund under K.S.A. 68-1135 et seq. \$275,000.00 to the Special Machinery Fund (Fund #144). **Resolution 2025-48-A – Transfer from Road & Bridge Fund to Special Bridge Reserve Fund**

Commissioner Tom Barrett made a motion that the Board of Commissioners adopt and execute Resolution No. 2025-48-A transferring from the Road and Bridge Fund under K.S.A. 68-1135 et seq. \$103,648.31 to the Special Bridge Reserve Fund (Fund #141). ## **Resolution 2025-49-A – Transfer from Road & Bridge Fund to Special Highway Improvement Fund**
