

## **Labette County Board of Commissioners**

### **January 26, 2026**

#### **Convene**

Chairman Tom Barrett called the regular session of the Labette County Board of Commissioners to order at 9:00 a.m. on January 26, 2026, at the Commission Room. Attendance: Tom Barrett, Present, Vincent B. Schibi, Present, Terry Weidert, Present.

#### **Others Present for the Meeting**

#### **Approval of Minutes**

Commissioner Terry Weidert made a motion to approve the minutes of January 20, 2026. Vincent B. Schibi seconded the motion. The motion passed by vote: Tom Barrett (Yes), Terry Weidert (Yes), Vincent B. Schibi (Yes).

#### **Position Transfer Form Signature**

Commissioner Terry Weidert made a motion to authorize the chairman's signature on a position transfer for the position of Undersheriff to be increased to \$77,614.95 annually. Vincent B. #### **Labette Center for Mental Health Services, Inc. – Agreement**

Commissioner Terry Weidert made a motion to authorize the Board of Commissioners' signatures on the Agreement for Services between the Board of County Commissioners of Labette County and the Labette Center for Mental Health Services Inc., from January 1, 2026, to December 31, 2026. Commissioners have agreed to levy taxes not in excess of 0.948 mill for 2026 to pay for mental health services for residents of the county. Vincent B. Schibi seconded the motion. #### **Foster Design Associates Agreement**

Commissioner Terry Weidert made a motion to authorize the Chairman's signature on an agreement between Labette County and Foster Design Associates for advisory services on an assignment basis related to zoning regulations for total compensation of \$2,500.00 annually.
