Convene

Chairman Terry Weidert called the regular session of the Labette County Board of Commissioners to order at 9:00 a.m. on June 20, 2023 at the Commission Room. Attendance: Cole J. Proehl, Present, Vincent B. Schibi, Present, Terry Weidert, Present.

Approval of Minutes

Commissioner Cole J. Proehl made a motion to approve the minutes of June 12, 2023 as submitted. Vincent B. Schibi seconded the motion. The motion passed by vote: Cole J. Proehl (Yes), Vincent B. Schibi (Yes), Terry Weidert (Yes).

Bid Opening – 9:05 A.M. – Building Purchase Financing

Chairman Terry Weidert opened the following bids for financing the purchase of the property at 1712 Corning:

Labette Bank, Parsons –Total Cost \$100,000.00 at 5.2% for ten years Bank of Commerce, Parsons –Total Cost \$100,000.00 at 5.3% for ten years

Commissioner Cole J. Proehl made a motion to accept the bid from Labette Bank at 5.2% interest and monthly payments of \$1,070.94 for ten years. Vincent B. Schibi seconded the motion. The motion passed by vote: Cole J. Proehl (Yes), Vincent B. Schibi (Yes), Terry Weidert (Yes).

Data Extract Agreement

Chairman Terry Weidert made a motion to authorize the chairman's signature on a data extract agreement among Blue Cross Blue Shield of Kansas, Labette County and Bukaty Companies, LLC, to have access on behalf of Labette County to obtain data for analyses reporting. Cole J. Proehl seconded the motion. The motion passed by vote: Cole J. Proehl (Yes), Vincent B. Schibi (Yes), Terry Weidert (Yes).

Labette County Senior Services

SEK-AAA Executive Director Kathy Brennon and Stacey Dickerhoof, discussed with Commissioners their request for 2024 Senior Services Budget funds. Ms. Brennon explained all the services provided with the funds especially the nutrition program. Their request was for \$35,000.00.

LSSE Grant

Emergency Manager Charles Morse, spoke with commissioners about the possibility of applying for a Local Safety and Security Equipment Grant for \$250,000.00 that could help fund one hundred new 800 MHz radios for ten rural emergency and fire departments.

Chairman Terry Weidert made a motion to authorize a total fund match of \$46,500.00, paid from a tribal allocation received by the county. The expectation will be that each of the local entities will reimburse the county for the \$1,250.00 for their share of the radios, since there is a time constraint for submitting the grant.

Sewer District #1 Bids

Chairman Terry Weidert made a motion to reject both bids for the Sewer District #1 project that were received on May 31, 2023. Vincent B. Schibi seconded the motion. The motion passed by vote: Cole J. Proehl (Abstain), Vincent B. Schibi (Yes), Terry Weidert (Yes).
