# **Approval of Minutes**

Labette County Health Department Director Lisa Scott gave the commissioners a few updates on her department. They are currently conducting interviews for an RN position.

#### **Bid Discussion**

Chairman Terry Weidert opened a discussion concerning the bids that were received on March 11, 2024 for the Public Works maintenance facility and Sheriff compound. Chairman Weidert stated that he was not comfortable with the amounts of the bids that were received. He met last week with Public Works Director Sandy Krider, Assistant Public Works Director Ralph George, Sheriff Darren Eichinger and Undersheriff Greg

Haraughty to discuss repairing the existing facility and also moving the Sheriff's impound storage to a different facility across the street with the addition of a fence. Commissioner Cole J. Proehl and Commissioner Vincent B. Schibi agreed that they were not on board to accept any of the bids at such a large expense. The commissioners agreed to discuss the subject further later in the meeting when Public Works Director Sandy Krider and Assistant Public Works Director Ralph George were on the agenda.

#### **Judicial Center Fence Discussion**

Commissioner Cole J. Proehl gave an update on the fence at the Judicial Center in Parsons. The project is expected to start on March 21, 2024.

## **Out of State Training**

Dispatch Director Brandy Scott met with the Commissioners to request approval to attend out of state training at the APCO International Conference in Orlando, Florida on August 4-7, 2024. Brandy has attended the conference in the past and feels that the training, classes, and networking is very beneficial. She also stated that the expense has been budgeted for. The Commissioners discussed the pros and cons of the conference. Commissioner Cole J. Proehl made a motion to approve the training request not to exceed a cost of \$2,500.00. Vincent B. Schibi seconded the motion. The motion passed by vote: Cole J. Proehl (Yes), Vincent B. Schibi (Yes), Terry Weidert (Yes).

Commissioners recessed their meeting for two minutes, and reconvened at 9:45 a.m.

#### **Dust Control**

Public Works Director Sandy Krider and Assistant Public Works Director Ralph George presented bids for dust control. Commissioner Vincent B. Schibi made a motion to accept the bid from Scotwood Industries, Inc. for dust control in Labette County. The 2024 cost will be \$428.80 plus sales tax for 400 feet (400 feet by 18 feet of roadway). An additional surcharge of \$50.00 will be added, which is the same charge as last year. Vincent B. Schibi seconded the motion. The motion passed by vote: Cole J.
