## Reconvene - Board of Health

Those present were Lisa Scott – Public Health Administrator, Tammie Murdock – Administrative Assistant, Pam Teetzel – RN, Angie Hammack - LPN, Jessica Smedley - Clerk, Tammy Bushong – Nurse Practitioner, Tracy Gilmore – Pharmacist-in-Charge, Brian K. Johnson – County Counselor, and Gena Landis – County Clerk. Health Department Administrator Lisa Scott played a video and presented a slide show about County Health Department roles and services.

Health Department Director Lisa Scott also spoke about the current measles outbreak. Commissioners granted the health department staff authorization to be voluntarily tested for measles immunity and be able to get vaccinated if necessary to avoid a lengthy quarantine should they encounter an infected patient.
