#### Convene

## **Approval of Minutes**

Commissioner Brian C. Kinzie made a motion to approve the minutes of November 8, 2021 as submitted. Cole J. Proehl seconded the motion. The motion passed by vote: Lonie R. Addis (Yes), Brian C. Kinzie (Yes), Cole J. Proehl (Yes).

## Closing of Courthouse - Year End Audit Purposes

## **Rotary Project**

Larry Kenemore with Rotary International, gave a presentation to Commissioners on Project SMART, which addresses the opioid crisis and polluted drinking water connection, due to improper prescription drug disposal.

### Board of Canvassers - 9:50 a.m.

Chairman Lonie R. Addis recessed the Board of Commissioners meeting at 9:50 a.m. and convened the Board of Canvassers to canvass the General Election of November 2, 2021.

The Board of Canvassers confirmed the vote count of 1985, which were counted through the DS450 Ballot Scanner. Election Clerk Becky Czapansky revealed the reasons for the thirty-two provisional ballots; fifteen complete provisional ballots were counted and four partial ballots were counted.

Chairman Lonie R. Addis recessed the Board of Canvassers and reconvened the Board of County Commissioners at 10:27 a.m. Clerk Gena Landis left the meeting at that time to run provisional ballots, and Payroll Clerk Amy Wilkinson took minutes.

County Clerk Gena Landis returned to the Commission meeting at 10:51 a.m.

#### **Noxious Weed Chemical Bids**

Noxious Weed Supervisor Ralph George presented the Commissioners with a spreadsheet of the chemical bids from three suppliers – the quotes include Escort, Outrider, Glyphosate, 2,4-D Amine and Surfactant (these chemicals will be for county use only):

Nutrien Solutions \$24,613.50 Van Diest Supply \$23,540.35

Bartlett Co-Op \$27,300.25 (Patriot)

\$28,199.45 (Escort)

Commissioner Lonie R. Addis made a motion to authorize the Noxious Weed Department to purchase the 2022 chemicals from Van Diest for a total cost of \$23,540.35, with the understanding that if additional chemicals are needed, they will be purchased through Bartlett Co-Op. The purchase is payable from the Noxious Weed Fund, 128-128-3001. Cole J. Proehl seconded the motion. The motion passed by vote: Lonie R. Addis (Yes), Cole J. Proehl (Yes), Brian C. Kinzie (Yes).

#### **Reconvene Board of Canvassers**

Chairman Lonie R. Addis recessed the Board of Commissioners at 11:01 a.m. and reconvened the Board of Canvassers. There were two races that were tied and the Board of Canvassers followed protocol in the Kansas Election Standards for breaking those ties. The race for Labette City Council fifth position, had a four-way tie between Dalton Jones, James Smith, Bobbi Peplinski, and Jason Peplinski, all receiving four write-in votes each. Commissioner Brian C. Kinzie broke the tie by drawing James Smith out of a hat.

The Labette City Mayor race had a two-way tie between John Collins and Nick Beery with ten votes each. Cole J. Proehl broke the tie by drawing Nick Beery from the hat.

#### **Board of Canvassers - Recessed**

Chairman Lonie R. Addis recessed the Board of Canvassers at 11:08, and reconvened at 11:24 a.m.

The provisional ballots were added to the totals bringing the grand total of ballots cast to 2004. The Board of Canvassers (Chairman Lonie R. Addis, Commissioner Brian C. Kinzie and Commissioner Cole J. Proehl) signed off on the November 2, 2021 City School General Election Abstract. Chairman Lonie R. Addis adjourned the Board of Canvassers and reconvened the Board of County Commissioners at 11:26 a.m.
