Road Closure Discussion

Land-owner Mike Hentzen spoke with commissioners about the possibility of closing 25,000 Road east of Lyons and placing a gate approximately fifty feet before the entrance to his property.

Commissioner Terry Weidert made a motion to permit Mike Henten to put up a gate approximately fifty feet before the entrance to his property with the knowledge that this is still a public road and will be a temporary gate. He needs to provide a key to the Public Works Director and if there is a valid complaint, he would need to remove the gate. This is effective on November 26, 2025. Vincent B. Indigent Defense Agreement – Adamson–2026
